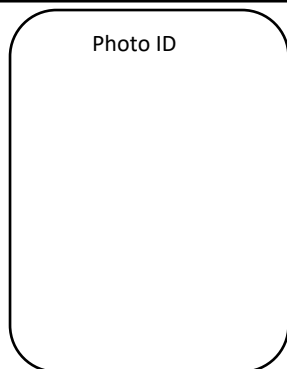

Pit Rental: Coming soon!!!

PLEASE ENSURE THAT THERE IS NO SPILL OVER INTO OTHER PITS OR THE ACCESS ROADS.

Members are reminded that the rented pits are essentially for members use only.

Please therefore encourage your non-member rider/competitor friends to get their own membership & upgrades otherwise they will not be allowed to pit in your area on race day/s unless the arrangement is for a dedicated ONE EVENT rental only.

Non-members will not be allowed to pit in the member's enclosures on practice days unless prior arrangements have been made or they are accompanied by the pit owner/s. If basic rules are not followed, we will not be able to control overcrowding.

On race days, the entry control attendant for the Upgraded Members VIP area will only allow the rightful owner/s to enter the VIP enclosure & occupy the correct pit. Access will be denied should an upgrade member fail to provide WETHERD MX PARK member identification card for self or accompanying pit crew as the registered pit owner/s. Please report to the coffee shop for clarification & approval to enter should access be prevented. Therefore, please ensure that WETHERD MX PARK has the information to record all the names of the fellow members that should be allowed to share the pit on race or practice days. Please make separate SPECIAL arrangements for All pit crew that arrive with own vehicle afterwards otherwise they will not be allowed to park in the private pit. Private vehicles should preferably remain in the general public parking area.

On formal Race days/events Wetherd MX PARK will have medics, officials & visitors from other regions, plus the factory teams that will require prime paddock space. Members will be contacted ahead of time about the race event to confirm by return mail whether they will be competing in the event. If so, the pit will not be allocated to others & members are most welcome to enjoy the benefits of "UPGRADED PIT" ownership on race days. To allow pits to stand empty on race day can be somewhat negative; therefore, subject to pit owner's prior consent, WETHERD MX PARK may allocate private "unused" pits to the race teams for the day.

Entry as a spectator to any of our formal race / event days is currently R20 per person for all visitors to WETHERD MX PARK. See race calendar on the website!

2020 -WETHERD MX PARK - Rules & Safety Guidelines

Registration at the WETHERD MX PARK reception/coffee shop is compulsory for everyone. Riders & all visitors to be recorded & processed in order to receive access to the track/spectator area

The respective entry fee/s must be recorded for every person entering WETHERD MX PARK

Operating Hours:

- Monday – Friday: 09h00 – 18h00.
- Saturday – Sunday: 08h00 – 15h00.
- Public holidays: 08h00-15h00.
- Christmas and New Years' Day: CLOSED

NO REGISTRATION – NO ACCESS! – NO RIDE!

The practice day register / indemnity form must be signed by non-member riders & everyone else that will partake in formal activities within the boundaries of the entire venue. All club members are registered via the once off "Annual Indemnity". All children under the age of 18yrs must be accompanied by a responsible adult.

WETHERD MX PARK reserves the right of admission.

Practice/ day riding fees

1. Basic member: R100 per rider per day – Membership cards can only be used by the membership holder, no one can use another member's card.
2. Non-Member: R120 per rider per day
3. Bronze, Silver and Gold membership: unlimited riding – no daily fee
4. Enduro Parking: R60 per vehicle per day – in designated parking area only

Membership Fees

5. Basic member: R500 annual fee (valid for a calendar year, no pro-rate rates)
6. Bronze Member: R350 monthly fee for 12 months / pro rata for remainder of the calendar year
7. Silver Member: R1900 fee Biannually (Valid January to June 2020 / July to December 2020)
8. Gold Member: R3500 Annual fee (Valid January to December 2020, no pro rata rates)

Pit Area – Coming soon!!!!

9. The speed limit is strictly **10kph** (walking speed – 1st Gear ONLY). This applies to cars and bikes. Offenders will be asked to pay a fine of R300 and upon their 3rd fine they will be asked to leave. This is for the safety of everyone, especially the children.
10. No disposing of oils or any other fluids at WETHERDMXPARK other than in the designated & labelled drum/s positioned at the wash bay area.
11. **ALL BIKES PARKED ON LAWN AREAS MUST COMPLY WITH THE USE OF ENVIRONMENTAL MATS!**
12. Suitable emergency temporary mats are available at reception or from the coffee shop. **-NO MAT – NO RIDE**



13. NO WHEEL SPINNING on the lawn areas – Offenders will be charged an equivalent ride fee to repair the damage. BE SENSIBLE & AWARE OF YOUR OWN ACTIONS AT ALL TIMES! Offenders will also be asked to pay a fine of R300 and upon their 3rd fine they will be asked to leave.
14. **NO BIKES TO BE OPERATED OUTSIDE THE FENCE BOUNDARIES** - Please respect the lawn areas. The Jnr track is suitable for novice and beginner riders. The JETTING STRIP is for race days only or by special permission. Transgressors will be asked to pay a fine of R300 and upon their 3rd fine they will be asked to leave.
15. The VIP pit area is a reserved built pit area for the exclusive use by the VIP pit owner only. ONLY bikes belonging to the WETHERD MX PARK VIP pit owner/s. **Damage to lawn will be for pit owner's account, therefore please control the activity in own pit.**
16. No open fires or cooking of food will be allowed in non-designated areas. The Coffee Shop has full catering facilities. Braai facilities are available in safe zones around the pit and camping areas.
17. Rubbish to be put in the bins provided. All visitors remain responsible for their own area. Appreciate that we are all guests on the premises, therefore please behave appropriately. Offenders will be warned and may be asked to leave the venue.

Wash Bay Area – Coming soon!!!

1. Ample wash bays are provided for your pleasure. Do not abuse the facility. Use water sparingly.
2. Power for electrical pressure washers on practice days is not guaranteed. It will be subject to generator activation & capacity on the day. There will however be free flowing low-pressure water at all times.
3. Pressure washers are not supplied by WETHERD MX PARK – please bring your own.
4. Please only use environmentally friendly bike shampoo / detergents. No Solvent based detergents allowed.

On the track + Rider Conduct

1. No helmet no ride. Offenders will be asked to pay a fine of R300 and upon their 3rd fine they will be asked to leave
2. No speeding off track. Offenders will be asked to pay a fine of R300 and upon their 3rd fine they will be asked to leave
3. Abusive language or intimidation will not be tolerated. Disagreements can always be resolved.
4. Do not stop on any jumps if other riders are still riding on the track, unless it is to shield a fallen rider.
5. Respect faster/ slower riders by being courteous during practice and keep to your lines.
6. **Exit or enter the track at the designated entry/ exit lanes ONLY – unless in emergency!** This action is considered reckless and damages the landscaped berms.
7. All bikes to be track worthy. It remains the sole responsibility of the rider to ensure his/her bike is in a mechanical standard that will not constitute a hazard.
8. Any incidents on the track or complaints of any nature must be reported directly to management who will adjudicate & take the necessary action to remedy the situation. Social media rants are frowned upon & may lead to the individual/family being considered “persona non grata”, with resultant permanent exclusion from the venue in future.
9. Ride within your limits and abilities – Ambulances & hospital care are expensive. Medical expenses are for your own account.
10. No riding after the consumption of alcohol. Drink & drive responsibly.
11. Respect the marshals; they are there for your safety.
12. Slow down & do not jump when a danger flag is out.
13. Medical personnel & vehicles have the right of way at all times. It is an offense to interfere with medical personnel whilst they are administering treatment. Please keep a respectful distance & follow the recommendations of the qualified personnel. Should treatment be refused or medics are interfered with, the legal responsibility transfers directly to the patient/offender. Medical expenses and treatment will be for your own account.
